### Delta and Econet weigh down the market...

The ZSE faltered in month opening as Delta and Econet weighed down the market. Beverages group Delta succumbed 12.04% to \$4.4528 while, telecoms giant Econet dipped 7.97% to close at \$2.2902. Property concern ZPI let go 3.04% to end pegged at \$0.0702 while, fast foods group Simbisa retreated 2.12% to settle at \$2.0650. Old Mutual sealed the top fallers' pack on a 0.39% drop to \$47.8009. The top gainers of the day were Edgars and SeedCo which surged a similar 19.88% to end at respective prices of \$0.3105 and \$2.4000 post release of Q3 trading update by seed processor. Apparel retailer Truworths gained 19.74% to \$0.0273 while, Mash advanced 1967% to \$0.1375. Dairibord wrapped the top five risers of the day on a 19.62% jump to \$0.6988.

Twenty-one counters registered price movements distributed as thirteen winners and eight losers to establish a positive market breadth of five. Activity aggregates closed in the red with volumes traded plunging 54.18% to 7.46m while, turnover shed 51.46% to \$18.17m. First capital and OKZim claimed 52.45% and 19.91% of the total volumes traded respectively. Anchoring the value outturn were Old Mutual and Padenga which accounted for a combined 69.32%. The primary All Share Index slipped 1.37% to 327.50pts while, the Industrial Index went down 1.38% to 1094.06pts. The ZSE Top Ten Index trimmed 2.99% to close at 302.87pts with Mining Index remaining stable at 344.92pts.


