Old Mutual leads market rebound...

ZSE rebounded in week-ending session as heavy capitalised stock Old Mutual spurred the market gains. The mainstream ZSE All Share Index gained 1.06% to 233.31pts while, the Industrials added 1.07% to 777.88pts. The ZSE Top Ten Index ticked up 1.28% to 218.78pts while, the Mining Index was stable at 301.96pts. Driving the market gains were hotelier RTG that rose 18.19% to \$0.01150 as Insurance giant Old Mutual surged 16.71% to \$35.0121 while, banking group First Capital extended 4.69% to \$0.1050. Other gains for the day were seen in OKZim and Meikles that put on 1.24% and 0.24% as the duo settled at respective prices of \$0.5619 and \$1.5200. Seven stocks traded in the red with notable losses seen in Dairibord that shed 7.19% and closed at a price of \$0.3847 trailed by, SeedCo which lost 0.74% to trade at \$1.9992. Beverages company Delta declined0.70% to end pegged at a vwap of \$3.8332 while, Cassava retreated 0.53% to \$1.6000. Wrapping the shakers was Axia which slipped 0.45% to \$0.6575.

Twelve counters registered price movements in the session as five gained against seven fallers to set a negative market breadth of two. Activity aggregates improved in Friday's session with volumes jumping 31.87% to 2.58m shares while, turnover soared 27.23% to \$6.64m. Top traded counters by value were SeedCo, Econet, Old Mutual and Delta which claimed 39.21%, 23.17%, 21.72% and 10.67% apiece. The duo of SeedCo and Econet anchored the volume aggregate with a combined contribution of 77.80%.


