ZSE falters in week opener...

The ZSE commenced the new week in losses as the four benchmark indices closed pointing southwards. The primary All Share Index lost 0.23% to 232.78pts while, Industrial Index shed 0.10% to 777.11pts. The blue chips index retreated 0.35% to 218.02pts. The top casualty of the day was nickel miner Bindura that succumbed 18.75% to \$0.1300. Resultantly, the Mining Index went down 7.84% to 278.28pts. ZHL let go 16.63% and settled at \$0.0712 while, insurance group Old Mutual was 1.40% down to end at a vwap of \$34.5231, having traded an intraday low of \$34.2000. Telecoms giant Econet trimmed 1.24% and settled at \$1.8049 while, Cassava shed 0.49% to \$1.5921. Dairibord led the risers' pack with a 16.97% jump to \$0.4500, trailed by property group Dawn that advanced 16.67% to \$0.0700. Art gained 11.90% to \$0.1410 while, retailers OKZim rose 3.22% to \$0.5800. Conglomerate Meikles completed the top five risers of the day having gained 2.19% to settle at \$1.5533.

Risers and fallers spectrum was equally distributed at eight as four counters remained unchanged. Market spend dropped 52.51% to \$3.15m while, the volume of shares traded slipped 23.88% to 1.96m. Volume drivers of the day were Dairibord (16.55%), Delta (16.37%), Econet (12.81%), SeedCo (12.02%) and Star Africa (10.62%). Top value leaders of the day were Delta, SeedCo and Econet with respective contributions of 39.01%, 14.96% and 14.39% of the aggregate.


