All Share and Industrials reach new year highs...

The mainstream All Share, and the Industrial Indices reached new year highs in today's session as the duo gained 4.72% and 4.71% to close at 1,815.03pts and 6,027.63pts, respectively. The ZSE Top Ten Index rose 5.58% to 1,166.41pts buoyed by heavies which continued to surge. The resources index improved 5.26% to end at 3,268.23pts, spurred by gains in RioZim which garnered 19.56% to settle at \$10.7606. Cigarette manufacturers BAT jumped 19.99% to end pegged at \$339.8000. Banking groups NMB and CBZ advanced 16.81% and 16.62% to close at respective prices of \$2.9592 and \$38.4833. Hotelier African Sun completed the top five winners of the day on a 13.97% lift to \$1.8000. Other notable gains were in Cassava (+6.90%), Delta (+6.44%), Econet (+4.21%) and Innscor (+1.09%).

Leading the fallers' pack was Star Africa that let go 7.59% to \$0.2411, trailed by Mash which declined 3.04% to \$0.6409. Property concern Dawn slipped 0.79% to \$0.6250 while, ZHL lost a further 0.28% to set at \$2.6000. FMP capped the fallers of the day on a 0.11% slide to end at \$2.1976. The market closed with a positive breadth of twenty as twenty-five counters gained against five losers. Activity aggregates were mixed in the session as volumes traded retreated 14.25% to \$7.84m while, turnover went up 15.44% to \$54.57m. Top volume drivers of the day were Cassava and Axia that contributed 24.75% and 13.25% apiece. Delta, Cassava and Innscor claimed a combined 51.44% of the value outturn.
