ZSE breaks twelve session losing streak...

The market rebounded in week ending session, breaking its twelve-session losing streak, ahead of the holiday extended weekend. The All share Index added 0.13% to 180.05pts while, the Industrials gained 0.14% to close at 600.56pts. The ZSE Top Ten Index rose 0.24% to settle at 166.66pts. The Mining Index was stable at 244.79pts with no trades in Bindura and RioZim. Two counters traded in the positive territory, headlined by Old Mutual that surged 3.02% to close at \$21.3589 having traded an intraday high of \$21.5000 on firming demand. Cassava followed on a negligible 0.05% lift to settle at \$1.3025 as the group closed with a spread of \$1.3025-\$1.3975.

Losers were led by Willdale which trimmed 19.25% to \$0.0172, trailed by Powerspeed that slipped 0.69% to end at \$0.3575. Completing the fallers of the day was Econet which retreated 0.14% to close at \$1.3500. Activity aggregates were mixed in Friday's session as volumes declined 77.74% to see 1.04m shares exchange hands while, value outturn ballooned 483.38% to \$3m. Top volume drivers were Delta, FBC and Powerspeed with respective contributions of 22.03%, 16.18% and 13.55%. Heavies Old Mutual and Delta were the major value drivers of the day accounting for 55.31% and 26.63% of the aggregate apiece.


