ZSE weakness persists into the new week...

The equities market commenced the new week in further losses with three of the benchmark indices closing in the red. The mainstream All Share Index was down 1.04% at 232.48pts while, the Industrial Index lost 1.05% to 773.81pts. The blue chips index let go 1.65% to close at 206.44pts while, the Mining Index was stable at 331.59pts. Leading the fallers' pack was multi-listed group Old Mutual that succumbed 5.18% to \$34.0733, trailed by Cassava which trimmed 3.07% to \$1.4227. Beverages group Delta dipped 1.44% to \$3.4763 while, retailer OKZim retreated 1.06% to \$0.7394. Completing the top five shakers of the day was brick manufacturers Willdale which came off 1% to settle at \$0.0297.

Zimplow headlined the risers of the day on a 7.84% surge to \$0.5500. Powerspeed followed after putting on 6.32% to end pegged at \$0.3700. Property concern FMP ticked up 2.80% to \$0.1650 while, spirit manufacturers AFDIS gained 1.67% to close at \$3.0500. Dairibord completed the top five gainers of the day on a 1.49% lift to \$0.3405. Ten counters rose against fifteen fallers to see the market close with a negative breadth of five. Activity aggregates were mixed in Monday's session with the volume aggregate adding 2.09% to 8.54m while, turnover dropped 25.52% to end at \$9.81m. The volume leaders of the day were Zimplow, ZPI and Mash that claimed a combined 54.25%. Top value drivers of the day were Delta, Old Mutual and Zimplow with respective contributions of 23.73%, 16.84% and 13.80%.
