Heavy caps drag ZSE into the red...

The market slipped into the red in Thursday's session as losses in market heavies weighed down the indices. The ZSE All Share Index and the Industrials lost an identical 0.03% to close at 233.30pts and 778.87pts apiece. The blue chips index let go 0.55% to 217.61pts while, the mining index was stable at 278.28pts. Leading the shakers of the day was dual listed PPC that succumbed 16.44% to settle at a vwap of \$3.5433. Simbisa brands followed on a 2.35% slide to \$1.4452 as telecoms giant Econet came off 2.31% to \$1.7871. Delta trimmed 1.20% and reached \$3.7500 while, Cassava wrapped the fallers of the day after retreating 0.63% to \$1.5805.

Pharmaceutical group Medtech headlined the winners of the day after a 38.46% surge to \$0.0072, trailed by Mash which gained 20% to \$0.0696. Apparel retailer Truworths garnered 19.80% and settle at \$0.0242 while, electrical group Powerspeed rose 14.46% to \$0.3205. Insurance company FML completed the day's gainers on a 14.29% lift to \$0.2400. Values traded dipped 51.90% to \$4.17m while, volumes exchanged went up 14.14% to 6.24m shares. ZPI and Mash anchored the volume aggregate with respective contributions of 27.09% and 22.77% to the total. Delta was the top traded stock by value claiming 42.41% of the outturn.
