# ZSE downward spiral continues...

Financial institution Getbucks' block trade highlighted the mid-week session as 33,088,950 shares worth \$1.10m exchanged hands in the counter claiming 88.97% of total volumes and 39.37% of the value outturn. Volume of shares traded ballooned 1,324.76% to 37.19m as value outturn for the day was \$2.80m. Other notable value drivers were Old Mutual and Axia with respective contributions of 23.98% and 10.16%. The risers and fallers' spectrum were equally distributed at nine apiece respectively. The top five gainers of the day were led by property concern Dawn which put on \$0.0240 trailed by Masimba that put on 16.77% to \$0.0731. Clothing retailer Edgars regained 4.08% to close at \$0.0740 while, Dairibord was up 3.45% at \$0.1500 closing with a spread of \$0.1500-\$0.1704. Proplastics sealed the gainers' pack after gaining 3.27% to settle at \$0.1105.

Headlining the shakers' pack was ZPI that eased 17.48% to trade at \$0.0170 while, conglomerate Meikles shed 12.50% to \$0.3500. Financial services group Old Mutual let go 3.74% to end pegged at \$5.7852 closing well-offered at \$6.0000. Beverages group Delta lost 3.53% to end lower at \$2.3500 while, Simbisa brands wrapped the fallers of the day after trimming 0.94% to settle at \$0.4755. The All share index inched down 1.10% to close at 118.06pts while, the Industrials succumbed 1.12% to end at 397.01%. The Mining Index was stable at 163.38pts with trades only seen in Hwange which traded 4,567 shares at a stable price of \$0.0395.


