# Heavies buoys gains on ZSE...

Selected heavies spurred the ZSE marginal gains in week opening trades as the market continued to trade in the positive. The ZSE All Share Index and the Industrials gained 0.29% and 0.28% to close at 234.77pts and 782.24pts respectively. The Top Ten Index rose 0.36% to end pegged at 209.17pts. The resources index advanced 1.01% to 315.84pts, stimulated by nickel miner Bindura that improved 2.41% to \$0.1700. Brick manufacturer Willdale topped the risers of the day after surging 20% to close at \$0.0306. Fast foods group Simbisa put on 0.98% to \$0.1.2648 while, beverages company Delta added 0.93% to close at \$3.4825. Retailer OKZim capped the top five gainers of the day on a 0.73% lift to \$0.6625.

Padenga was the sole faller in today's session after the crocodile skin producer let go 1.29% to settle at \$2.4603. Turnover slipped 25.62% to \$4.82 while, volumes likewise dropped 15.29% to 2.76m shares. Top volume drivers of the day were Padenga (25.72%), Cassava (18.45%), Willdale (13.94%) and OKZim (12.78%). Padenga, Cassava and Delta anchored the value aggregate with a combined contribution of 64.37%. Foreign inflows at \$8,000 were 733.33% up from prior session's close while, foreign outflows increased by 42% to \$1.99m leaving a net funds outflow position.


