# ZSE in marginal gains in week opening session...

The two broad Indices, All share and Industrials gained an identical 0.63% to end at 103.89pts and 347.67pts respectively. The Top Ten Index extended 0.84% to close at 105.97pts on the back of trades in heavies SeedCo, Old Mutual and Econet. The Mining Index was stable at 132.96pts for the third consecutive session with trades only seen in RioZim which traded unchanged at \$1.2400. Twelve counters registered price movements with eleven trading in the positive territory while, only one counter was in the negative to record a positive market breadth of ten. OkZim was the sole faller of the day after dropping 1% to settle at \$24.75, closing well offered at \$0.2500. Headlining the risers for the session was crocodile skin manufacturers Padenga which put on 6.45% to \$0.6600 trailed by SeedCo which rose 4.96% to \$2.1499 having touched an intra-day high of \$2.1500, closing with a bid at \$2.1500. Clothing retailer Edgars went up 3.59% to \$0.0520 while, multi-listed Old mutual added a hefty 2.78% to close at \$7.0085, traded an intra-day high of \$7.0100 on rising demand. Completing the top five risers of the day was Proplastics which advanced 2.13% to \$0.0766.

Activity for the session was depressed as volumes plunged 52.67% to 2.65m shares while, value outturn dropped 56.60% to circa \$1.49m. Anchoring volumes traded were Barclays, Zimplow and Delta with respective contributions of 36.76%, 16.80% and 12.35%. The duo of Delta and RioZim accounted for 44.35% and 12.22% respectively to the value aggregate. Foreign purchases shed 37.04% to \$0.93m with no foreign sales for the day to set a net funds inflow position.


