Activity aggregates surge in Tuesday's session ...

Tuesday's session was characterized by a surge in activity aggregates as volume of shares traded ballooned 211.67% to \$8.26m while, turnover enhanced 125.23% to settle at \$3.36m. ZPI, Econet and Mash were the major volume drivers with a combined contribution of 79.52% to the outturn. Econet and Delta accounted for 59.43% and 20.81% of total value for the day. Foreign inflows stood at \$2 426 270.98 while, outflows were \$46,107 to set a net funds inflow position. The market registered eleven risers against a mere two fallers to record a positive breadth of seven. Leading the market charge was banking group CBZ which advanced 9.09% to close at \$0.1200 while, dual listed PPC extended 6.90% to settle at \$1.2000. SeedCo was 3.94% up at \$2.2345, traded an intra-day high of \$2.2500 while, Dairibord rose 3.34% to end at \$0.1700. Trading in the negative territory was property concern Dawn which let go 17.72% to \$0.0130 trailed by Mash that lost 10.20% to settle at \$0.0220. The duo of ZPI and Axia wrapped the fallers of the day after dropping 7.89% and 1% to \$0.0175 and \$0.2475 respectively.

The mainstream, All Share Index ticked up 0.35% to close at 104.25pts while, the Industrial Index added 0.31% to 348.76pts. The ZSE Top Ten Index put on 0.47% to 106.47pts buoyed by heavy caps SeedCo, Old Mutual, National Foods, Econet and Innscor. The Mining Index went up 1.98% to 135.59pts lifted by nickel miner Bindura with an 8.46% lift to \$0.0423, as no other trades were recorded in other mining counters.




