ZSE ends week in the red...

The market slipped into the red in week-ending session as three of the four benchmark indices closed pointing southwards. The ZSE All Share and the Industrial Indices lost a similar 0.07% to close at 228.19pts and 760.26pts apiece. The ZSE Top Ten trimmed 0.36% to 208.80pts weighed down by Econet, Cassava and Old Mutual. Banking group NMB led the fallers of the day after letting go 2.50% to settle at \$0.3900, trailed by Econet that came off 2.29% to \$1.6505 closing with a spread of \$1.6500-\$1.7000. Banking group First Capital went down 1.60% to \$0.0984 while, Cassava retreated 0.67% to \$1.4680 having traded an intra-day low of \$1.4600. Axia completed the top five shakers of the day on a 0.14% slide to \$0.6496.


SeedCo Limited headlined the winners of the day after putting on 10% to end pegged at \$2.2000 while, Star Arica followed on a 3.57% jump to \$0.0290. Ariston gained 1.61% to \$0.1260 while, retailer OKZim extended 0.65% to \$0.6500. Nickel miner Bindura advanced 1.54% to \$0.1320 leading to a 0.51% improvement in the Mining Index to 310.18pts. Gainers outnumbered fallers by a count of six to see the market close with a positive breadth. Volumes traded jumped 88.80% to 4.54m shares, yielding a value outturn of \$12.72m. Top volume drivers of the day were Delta, Cassava, Econet, Padenga and Axia with a combined contribution of 67.77%. Top value drivers of the day were Old Mutual, Delta and Padenga which accounted for 21.73%, 21.50% and 11.41% respectively.
