ZSE softens in midweek session...

The market continued to falter in midweek session on the back of losses in heavy caps. The primary All Share Index retreated 2.82% to 502.41pts while, the Industrials came off 2.99% to 1673.08pts. The blue chips index let go 5.04% to end pegged at 447.46pts. Construction group Masimba led fallers' pack after trimming 16.59% to \$0.2740 while, ZHL followed on a 15.34% plunge to \$0.4233. Telecoms giant Econet succumbed 8.59% to \$3.3602 while, Fintech group Cassava dropped 8.55% to settle at a vwap of \$3.3335. Retailer OKZim completed the top five shakers of the day after shedding 5.84% and closed at \$2.2925.

Apparel retailer Truworths surged 20.09% to \$0.0562 while, Hippo and Medtech jumped an identical 20% to close at \$4.8000 and \$0.0432 apiece. Property concern ZPI extended 19.92% to \$0.1445. The Mining Index added 10.30% to 612.38%, buoyed by Bindura that grew 19.89% to \$0.4340. The market registered a positive breadth of five after twenty-one counters rose against sixteen that lost the ground. Activity aggregates were mixed as seen in volume that ballooned 249.96% to 40.57m while, turnover dipped 32.42% to \$22.38m. Truworths and Willdale contributed 69.19% and 17.43% to the volume aggregate respectively. Value outturn was anchored by Innscor, Econet and Delta that claimed a combined 65.26% of the gagregate.
