Market closes week in the black ...

The market ended week in the black as three of the benchmark indices continued to trek northwards. The primary All Share and the Industrial Indices rose 1.33% and 1.39% to close at 180.93pts and 607.59pts apiece. The Top Ten Index advanced 1.11% to 191.48pts spurred by gains in Padenga, Hippo and Old Mutual despite losses in Delta and SeedCo. Proplastics and SeedCo International gained a similar 20% to end at \$0.1740pts and \$1.0500 respectively. Padenga was also on the upside after advancing 19.79% to \$0.8625 while, Turnall improved 19.05% to \$0.0500. Hippo firmed 16.67% to end pegged at \$2.8000 closing with a spread of \$2.2000-\$2.8000.

Nickel miner Bindura let go 5.81% to end pegged at \$0.0810 dragging down the Mining Index as it settled at 225.61pts after tripping 1.73%. Clothing retailer Edgars was also on the downside after retreating 3.33% to \$0.1595 while, beverages company Delta trailed with a 0.33% loss to \$3.5500. SeedCo Limited completed the four shakers of the day after trimming off a marginal 0.02% to \$2.5500 closing well-offered at that level. The market was bullish as gainers outnumbered fallers by a count of fourteen to set a positive breadth. Market activity was rather subdued as seen in volumes that tumbled 62.12% to 10.09m shares and market spend which succumbed 83.63% to circa \$3.52m.


