# Industrials cap the week in the black...

The Industrials maintained the uptick in week ending trades on firming demand in the trio of top capitalized stocks Delta, Innscor and Old Mutual. The Industrial Index closed the week in the black after a 0.27% upsurge to 99.28pts buoyed by gains in five stocks. Innscor put on a hefty 4.81% to close the session at \$0.2005 with Old Mutual gaining a marginal 0.31% to \$2.2444. Delta added 0.69% to \$0.5943 as the stock continued to trek northwards following the release of its trading update with investors eagerly waiting for its FY16 results. Turnall also helped the market's rising impetus adding 9.09% to \$0.0120 closing well offered at the same level. Other gains of the day were seen in Sugar refiners Hippo that ticked up 1.95% to \$0.2350 while, conglomerate Meikles gained 0.55% to settle at \$0.07300 on firming demand. SeedCo was the sole faller of the day after shedding 3.45% to touch a low of \$0.5600 on a paltry 150 shares. The Mining Index was flat at 20.16pts with no activity in the cluster.

Local participation was the mainstay of the day as all foreign aggregates dipped. Foreign inflows dropped 65.79% to \$146,898 while, outflows succumbed 95.44% to \$12,977 on yesterday accounting for 18.9% and 16.7% respectively. Week ending aggregates enhanced further with the turnover surging 70.58% to \$0.78m while, volumes ballooned 1355.54% to 20.65m shares. Both outturns were anchored by a block trade in Dawn properties which contributed 95.73% in volume and 41.04% on value after 19.77m shares worth \$0.32m exchanged hands. Other notable trades were in Old Mutual, Delta and Natfoods which contributed for a combined 52.91% of the total value exchanged.
