ZSE slips into the red...

The market slipped into the red in Tuesday's session as the mainstream All Share Index came off 0.92% to 227.19pts while, the Industrials lost 0.74% to close at 756.67pts. The ZSE Top Ten Index let go 0.82% to 207.61pts. The Mining Index retreated 10.07% to close lower at 314.86pts weighed down by RioZim which dropped 15.58% to \$2.6000. Banking group CBZ let go 9.09% to end pegged at \$0.6000 while, SeedCo Limited trimmed 8.73% to \$2.0056. Banking group NMB shed 4.46% to settle at \$0.3726 while, Cassava dipped 3.20% to trade at \$1.4009 on waning demand.

Headlining the winners of the day was Proplastics which garnered 17.33% to \$0.8800, followed by Dairibord that surged 7.84% to \$0.5500. Zimpapers gained 4.17% to close at \$0.1000 while, nickel miners Bindura ticked up 1.96% to \$0.1350. Giant insurer Old Mutual added 0.69% to \$33.0066 completing the top five gainers of the day. Activity aggregates were mixed as volumes ballooned 106.20% to 8.87m shares while, turnover went down 28.90% to \$7.99m. Mash and Zimpapers were the top volume drivers accounting for 44.01% and 11.28% respectively. Heavies Old Mutual, Padenga, Innscor, Delta and Cassava claimed a combined contribution of 79.65% to the value outturn. Foreign purchases stood at \$102,776.00 against a nil position in sales to establish a net funds inflow position.


