ZSE commences new week in gains...

Gains on the ZSE persisted into the new week, sustained by Econet, Padenga and Delta. The primary All Share Index gained 2.07% to end at 494.42pts while, the Industrial Index rose 2.21% to 1639.64pts. The ZSE Top Ten Index went up 3.36% to close at 416.36pts. Property companies ZPI and FMP topped the risers' pack after jumping 20% and 19.78% to close at respective prices of \$0.1920 and \$0.8025. Telecoms giant Econet advanced 15.30% to end at \$2.9985 while, crocodile skin producers Padenga surged 8.11% to settle at \$6.0000. ART competed the top five winners of the day after putting on 5.81% to \$0.4550.

The Mining Index shed 4.58% to 762.76pts weighed down by nickel miner Bindura which succumbed 11.52% to \$0.3556. Conglomerate Meikles let go 9.69% to \$7.0894 with Dawn trimming 9.09% to \$0.1000. Giant Insurer Old Mutual retreated 4.14% to end at a vwap of \$43.6174, having traded an intraday low of \$42.0000. Hippo wrapped the fallers' pack on a 2.19% loss to \$7.0426. Twenty-three counters registered price movements in the session as gainers outnumbered fallers by a count of nine, to establish a positive breadth. Volumes traded ballooned 117.57% to 4.61m shares while, value outturn improved 42.06% to \$9.95m. Top volume drivers were Mash, ZPI and OKZim which claimed 32.53%, 17.35% and 11.19% apiece. Top value drivers were Delta, Old Mutual, Innscor, Cassava and OKZim with a combined contribution of 73.21%.


