# ZSE rebounds in mid-week session...

The ZSE benchmark indices rebounded in mid-week trades with the mainstream ZSE All Share Index gaining 1.97% to close at 231.67pts while, the Industrials advanced 2% to 771.82pts. The ZSE Top Ten Index rose 2.89% to settle at 213.61pts. Falcon gold spearheaded the gainers' pack as it garnered 20% to close at \$0.0300, trailed by Cassava which surged 12.69% to close at a vwap of \$1.5787. Insurance group FML ticked up 4.17% to \$0.2500 while, telecoms giant Econet added 3.23% to \$1.7338. Dairibord completed the top five gainers of the day with a 2.27% lift to \$0.5625.

Art led the shakers of the day on a 6.67% loss to \$0.1400 while, SeedCo Limited let go 4.63% to \$1.9127. Mining Index trimmed 0.23% to 314.13pts weighed down by Bindura that slipped 1.04% to \$0.1336. Property concern Dawn came off 0.49% to \$0.0806 while, crocodile skin producers Padenga shed 0.28% to end at a vwap of \$2.8898. The gainers of the day outnumbered the fallers by a count of seven to establish a positive market breadth. Volumes of shares traded dipped 64.48% to 3.15m yielding a turnover of \$7.07m which was a 11.50% decline from prior session. The top value drivers of the day were SeedCo, Padenga and Cassava with respective contributions of 31.90%, 13.27% and 13.19%. The top value drivers were Old Mutual (28.79%), SeedCo Limited 27.20% and Padenga 17.09%.


