ZSE falters in week-opener...

The market opened the last trading week of the month in the red as three of the benchmarks ended pointing southwards. The primary All Share Index lost a negligible 0.01% to 241.41pts while, the Industrial Index slipped 0.05% to 803.20pts. The ZSE Top Ten Index let go 0.10% to end at 217.76pts. The top loser of the day was Truworths that succumbed 19.29% to \$0.0226, followed by Bindura which came off 2.79% to \$0.1637. Beverages manufacturer Delta retreated 0.83% to \$3.8377, closing with a spread of \$3.8000-\$3.8500. Banking group CBZ trimmed 0.40% to \$0.6200 while, retailer OKZim was 0.32% down at \$0.7875.

The Mining Index added 2.15% to close at 348.92pts as gains in Riozim offset losses in Bindura. RioZim led the risers of the day on a 5.48% jump to \$2.7425, trailed by banking institution First Capital that ticked up 1.66% to \$0.1043. Cement manufacturers PPC advanced 1.67% to \$4.5820, closing well-offered at \$5.2800. Telecoms giant Econet improved 0.82% to \$1.6806 having traded an intraday high of \$1.6900. SeedCo Limited wrapped the top gainers' list on a 0.43% lift to \$1.7826. The gainers and fallers' spectrum was equally distributed at eight apiece. Volumes traded dipped 57.17% to 2.48m shares as Truworths, Medtech and Cassava claimed 19.79%, 18.32% and 17.27% respectively. Turnover was down 6.28% at \$2.66m as Cassava, Delta, Old Mutual, PPC and Econet anchored the aggregate with a combined contribution of 72.11%.


