## Bullish Industrials sustain gains...

The benchmark Industrial Index sustained its ascendency in Thursday trades notching 0.60% to close at 102.75pts. The bullish trend continued on the bourse as six of the thirteen active stocks ticked up while only one counter registered a loss as the market established a positive breadth of five. Leading the market charge was construction allied products manufacturer Proplastics that surged 10% to \$0.0275 on buoyant demand while TSL followed with a 7.41% jump to \$0.1450. Banking group Barclays extended gains from yesterday with a 2.79% lift to \$0.0295 successfully overcoming jitters in early trades that saw the group slip to \$0.027 in intraday trades. Delta anchored the rising momentum as it hived 1.56% and closed trading at \$0.6525 while, the duo of OKZIM and PPC helped the same cause with marginal gains of 0.24% and 0.17% to close trading at \$0.0411 and \$0.6500 respectively. Multilisted group Old Mutual was the day's sole decliner shedding 1.89% and closing at \$2.2026

The market saw improved trades on Thursday with funds exchanged surging 721.49% and ending the day at \$382,740. The top driver of value was Old Mutual were a notable 78,112 shares sailed on the board and yielded \$172,048 which represented 44.95% of the aggregate. Volumes of the day ballooned 200% and ended the day at 1,856,729 shares as the improved prices begin to draw in sellers. Volumes were largely driven by Willdale and GBFS with the duo accounting for a combined 48.78% of the total. Foreign Interest was also reignited in today's call resulting in inflows growing 1270% to \$129,722 and outflows surging 912.06% to \$145,868 leaving the market in a net funds outflow position. Meanwhile, the Mining Index remained perched at 20.16pts for the fourteenth successive session with no trades in the cluster.


