Bullish sentiment extends...

The bullish sentiment extended in Thursday's session with the All Share Index soaring 5.67% to reach 1100.21 pts while, the Industrial Index gained an identical 5.67% to land at 3650.56 pts. The ZSE Top Ten Index rose 4.83% to settle at 886.81 pts while, the Mining index added 5.49% to end pegged at 1561.41 pts, buoyed by nickel miner Bindura that put on 9.37% to trade at \$1.2021. Powerspeed topped the gainers' list after jumping 20% to close at \$1.2000 while, TSL was up 19.95% at \$4.7500. Meikles and SeedCo Limited gained a similar 19.91% to settle at respective prices of \$11.9400 and \$11.0800. Edgars capped the winners of the day on a 19.78% lift to \$1.0900.

Mash led the fallers of the day on a 12.65% drop to \$0.7000, followed by hotelier African Sun that slumped 2.10% to end at \$0.9317. Medtech eased 0.35% to \$0.1699 while, brick manufacturer Willdale pared 0.08% to \$0.1215, completing the four losers of the day. Forty-two counters were active in the session distributed into twenty-nine risers, four fallers and nine that traded at previous prices. Activity aggregates were mixed with volume of shares traded plunging 16.11% to 20.59m, yielding a turnover of \$49.76m which was a 102.87% jump from prior session. Willdale was the top volume driver for the second consecutive session claiming 66.59% of the outturn. Top value drivers of the day were Old Mutual (25.50%), Delta (14.14%) and Cassava (13.91%). Foreign purchases amounted to \$13.14m while, sales stood at \$7.78m, leaving the market with a rare net funds inflow position.


