ZSE caps the month mixed...

ZSE traded sideways in the last session of November as three of the benchmark indices closed in black while, one was in the red. The primary All Share Index gained 0.07% to 240.81pts while, the Industrials ticked up 0.04% to 801.38pts. The Mining Index rose 1.69% to 344.42pts buoyed by Bindura that put on 6.80% to \$16.0200. Apparel retailer Edgars jumped 15.16% to \$0.1550 while, Axia improved 12.59% to \$0.8050. Ariston went up 4.88% to \$0.2000 reversing previous day losses as, property concern ZPI advanced 4.62% to \$0.0680. The Top Ten Index slipped 0.06% to end pegged at 216.29pts.

Dawn properties headlined the fallers of the day after a 16.67% dip to \$0.0600 while, construction group Masimba succumbed 15.78% to \$0.1878. Hotelier African Sun let go 3.38% to settle at \$0.4348 while, banking group CBZ retreated 1.70% to \$0.6200. Completing the top five shakers of the day was RioZim that trimmed 1.09% to \$2.7200. Thirty-two counters were active in today's session distributed as sixteen gainers, twelve fallers and four that held ground. Activity aggregates surged in week-ending session as volumes ballooned 174.19% to 3.45m shares while, value outturn swelled 330.34% to \$4.85m. Volume leaders of the day were Bindura, Cassava, Delta and Padenga that claimed a combined 69.59% of the aggregate. Top value leaders of the day were Delta (29.13%), Padenga (20.63%), Old Mutual (18.63%) and Cassava (17.69%).


